Background and contents of this privacy statement

Stichting Kind Beter (Foundation Child Well) is aware that appropriate processing of personal data is of great importance. Processing is about everything that can be done with personal data, from saving to destroying. The General Data Protection Regulation (GDPR) lists 'collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction' as examples of processing data. In this privacy statement you can read which personal data Stichting Kind Beter (Foundation Child Well) processes and with which purpose we process data. The way in which Stichting Kind Beter (Foundation Child Well) operates is in accordance with the GDPR.

1. Controller

Mrs E. A.M. Kloosterman is the Controller of Stichting Kind Beter (Foundation Child Well) and can be contacted for questions about the way in which data are processed. She can be reached via the contact details above.

2. Personal data that we process

Stichting Kind Beter (Foundation Child Well) processes your personal data because you made a donation to our Foundation or because you reached out to us via our website, email or phone.

Stichting Kind Beter (Foundation Child Well) has access to your personal data, such as your name and bankaccount when you have decided to become a benefactor. Besides this we have access to your e-mailaddress when you have contacted us or when you start a campaign on behalf of Stichting Kind Beter (Foundation Child Well).

3. Purpose of data processing

Stichting Kind Beter (Foundation Child Well) will only use your data for the goals we want to achieve such as raising funds for the Foundation or inform you on our activities (e.g. Newsletter). At this moment Stichting Kind Beter (Foundation Child Well) doesn't have a Newsletter. Should this change in the near future you will only receive our Newsletter if and when you have subscribed. You can unsubscribe at any time.

Stichting Kind Beter (Foundation Child Well) will not use your data for any other purposes.

4. How long we store your personal data

Stichting Kind Beter (Foundation Child Well) does not store your personal data longer than is strictly necessary to achieve the purpose(s) for which your data is collected. We use the following retention period for the personal data:

Data of benefactors up to ten years after the donation, unless the law prescribes to keep them for a longer period. During this period it may be necessary that we still contact you or perhaps you would like to get in contact with us again. Your contact details can also be kept longer if you have indicated that you wish to remain informed;

5. Donation button on Geef.nl

The donation button on the website of Stichting Kind Beter (Foundation Child Well) will link you to the payment platform provided by charity- and crowdfunding website Geef.nl. Geef.nl has a privacy statement which can be viewed on <https://www.geef.nl/nl/page/privacy>.

6. Emaildata

Stichting Kind Beter (Foundation Child Well) uses the email services of Ziggo. If and when you email Stichting Kind Beter (Foundation Child Well) your email will be stored on the servers of Ziggo. Emails with no need for archiving will be deleted right away after reading. Every three months archived emails can be deleted.

7. Data in the financial administration

Stichting Kind Beter (Foundation Child Well) uses the services of third parties, such as BWK Administraties in Zoetermeer, for the financial administration. Stichting Kind Beter (Foundation Child Well) will do what's necessary to guarantee the confidentiality of all data.

8. Sharing your personal data with third parties

Stichting Kind Beter (Foundation Child Well) will not sell your information to third parties and will only provide this information to them to comply with a legal obligation.

9. Cookies, or similar techniques, that we use

Stichting Kind Beter (Foundation Child Well) uses technical and functional cookies. And analytical cookies that do not infringe your privacy. A cookie is a small text file that is stored on your computer, tablet or smartphone when you first visit this website. The cookies we use are necessary for the technical operation of the website and your ease of use. They ensure that the website works properly. We can also optimize our website with this. You can opt out of cookies by setting your internet browser so that it does not store cookies anymore. In addition, you can also delete all information previously saved via the settings of your browser.

10. View, modify or delete your personal data

You have the right to view, correct or delete your personal data. In addition, you have the right to withdraw your consent to the data processing or to object to the processing of your personal data by Stichting Kind Beter (Foundation Child Well). You can request access, correction or deletion; withdrawal of your consent; or object to data processing by sending an e-mail to kindbeter@ziggo.nl.

To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Your photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and social security number can not be visible on this copy. This is to protect your privacy. We will respond to your request as soon as possible, but in any case within four weeks.

11. Submitting a complaint

If you believe Stichting Kind Beter (Foundation Child Well) has made a mistake while performing its work, you can file a complaint. The board of Stichting Kind Beter (Foundation Child Well) will deal with your complaint, hear about your complaint and will make a decision about your complaint.

If you believe that your complaint has not been dealt with satisfactorily after completion of the procedure, you can send a complain to the Dutch national supervisory authority (Autoriteit Persoonsgegevens) within 6 weeks of receiving the decision of the board.

12. Updating our privacy statement

Stichting Kind Beter (Foundation Child Well) reserves the right to change this privacy statement at any time. Changes will be published on our website. We recommend that you regularly visit our website for the most recent version of this document.

This statement has been drawn up in both Dutch and English. If the English version shows differences with the Dutch version, we adhere to the Dutch version of this statement.
